

**Fetch Boarding and Kennels, LLC, dba Fetch Dog Daycare & Boarding  
Social Play Agreement**

While participating in daycare or overnight boarding, dogs will be interacting with humans and other dogs. Dogs may, without warning, bite or cause injury to humans and other dogs.

*Please read and initial all statements below:*

\_\_\_\_\_ I acknowledge and understand that there are certain risks involved in participating in daycare and boarding including, but not limited to dog fights, dog bites to humans or other dogs, and the transmission of disease.

\_\_\_\_\_ I acknowledge that every dog reacts differently and can be unpredictable at times.

\_\_\_\_\_ I understand that by admitting my dog(s) to Fetch Dog Daycare & Boarding dogs may experience separation anxiety.

\_\_\_\_\_ I understand that by admitting my dog(s) to Fetch Dog Daycare & Boarding, I am granting permission for my dog(s) to co-mingle and socialize with other dogs.

\_\_\_\_\_ I understand that higher levels of activity than my dogs may be used to may result in sore muscles and joints or fatigue, and high levels of outdoor play may result in tired, sore, or blistered feet until my dog gets used to being the environment.

\_\_\_\_\_ I understand any behavior deemed dangerous or inappropriate may result in dismissal from Fetch Dog Daycare & Boarding.

\_\_\_\_\_ I understand and agree by admitting my dog(s), that Fetch Dog Daycare & Boarding has relied on my representation of my dog(s) temperament and that my dog(s) have not shown aggression or threatening behavior towards any dog or person.

\_\_\_\_\_ I understand Fetch Dog Daycare & Boarding gives all dogs involved in any type of incident a snout to tail examination; however, Fetch Dog Daycare & Boarding is not liable for the location, treatment, or diagnosis of any injuries incurred on Fetch Dog Daycare & Boarding premises.

\_\_\_\_\_ I agree to hold harmless and indemnify, Fetch Dog Daycare & Boarding and its employees, invites, and guests from liability, claims, and damages, including reasonable attorneys' fees, for loss, injury, illness, and/or death caused by my pet to persons, other pets or property. I further release Fetch Dog Daycare and its employees from liability, claims and damages, including reasonable attorneys' fees, for any illness, injury, and/or death caused to my pet, unless resulting from gross negligence or willful misconduct.
